SHORT COURSES AUSTRALIA RENEWABLE LIQUOR LICENCE FOR TAKEAWAY BUSINESSES

Short Courses Australia (SCA) assist Takeaway Food Businesses, across Victoria, gain a licence to sell **Alcohol** with each **Takeaway** and **Home Delivery**.

SCA provide **contactless** end to end application support. Our consultants assist you to complete training via live teleconferencing, using **ZOOM, FaceTime or Skype** and then **Prepare, Submit** and **Monitor** the liquor licence application with **Victorian Commission for Gaming & Liquor Regulation (VCGLR)**.

Takeaway Food Businesses are **eligible** to obtain a **Renewable Liquor Licence** that allows the sale of **6 Units of Beer** or **6 Units Pre-Mixed** drinks or **1 Bottle of Wine** with each **Takeaway** or **Home Delivery** food order.

Until September 2020 the **Victorian Commission for Gaming & Liquor Regulation (VCGLR)** are waiving the licence application fee (\$480.80) to help takeaway businesses **Fast Track** the transition of their operations during COVID-19 trading restrictions.

This liquor licence requires that a meal **must** be ordered to allow **Takeaway** or **Home Delivery**.

You cannot just deliver alcohol.

A **Takeaway Liquor Licence** can generate an additional **\$10.00 to \$25.00** revenue per order, whilst helping to **Maintain & Win New Customers**.
